Course: Put in at DNR Site Pte. Tremble Rd. cross the North Channel to Grande Pointe Cut, proceed North in the South Channel to Canoe Cut. Enter Canoe Cut receive first card. Take the first canal to the right and proceed to the next canal. Turn left at the intersection and receive second card. Proceed west to the first canal on right, turn right and proceed North past the Ferry Dock and under the bridge. Collect third card and proceed North out of the canal and into the St. Clair River at the head of Russell Island. Paddle North and West to Snoopy's Canal and enter the canal, proceed West to Snoopy's Bar and get your fourth card. Turn around and paddle back to the river and then turn right and continue downstream to the Algonac City Boat Ramp, collect fifth card. Downstream around Pte. Du Chene and enter the Harbour Club Canal. Collect sixth card at the Harbour Club Restaurant. Return to river and go South to DNR Launch. Open your unopened envelopes in front of PPP Official.
